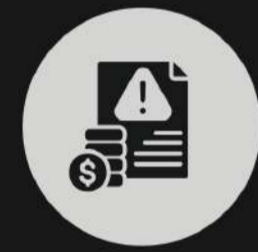

# How It Works?

For example

in a luxury car rental business valued at \$20 million, GVI might offer 40% of the shares for sale. This 40% could be divided among multiple investors, depending on the amount they choose to invest, providing flexible options to suit different investment levels.
